<u>Please note</u>: Students exiting early with one component of a dual degree must complete the single degree requirements of that component. Students will then be required to follow the single degree rules to complete the remaining component from that dual degree and maximum credit rules will apply.

PROGRAM GUIDELINES

You must complete a total of 88 units for the program comprising -

- 22 units of compulsory courses from Group 1 of the BBusMan List (not including LAWS1100); and
- 40 units of compulsory courses from Part A of the LLB(Hons) List; and
- 12 units for either-
 - one major in Group 2 of the BBusMan List including LAWS5136 (minimum 6 units must be at level 3); or
 - elective courses from Group 3 of the BBusMan List including LAWS5136 (minimum 6 units must be at level 3, and only 2 units may be at level 1); and
- 14 units of elective courses from Part B of the LLB(Hons) List (not including LAWS5136).
