- (b) 12 units from the [MEconPP \(24 units\)](#) course list, comprising –
 - (i) 8 units from Part A, excluding any courses counted towards rule (a)(i); and
 - (ii) 4 units from Part B, excluding any courses counted towards rule (a)(i) or (a)(ii)
