### PROGRAM GUIDELINES

You must complete 80 units, comprising -

- 30 units from the BCom component, including
  - 14 units for all BCom Core Courses for the BCom/LLB(Hons); and
  - o 16 units for a BCom Major from BCom Majors for BCom/LLB(Hons); and
- 48 units from the LLB(Hons) component, including
  - o 36 units for all LLB(Hons) Core Courses; and
  - 12 units from LLB(Hons) Flexible Core Courses; and
- 2 units of General Elective Courses

 LAWS5144 must be completed if taking an Accounting major (for professional accreditation purposes)
