1 GENERAL INFORMATION

Cross-institutional students undertake approved courses at The University of Queensland for credit towards their studies at their home institutions. They receive normal instruction, assessment and examination results but are not enrolled in a University of Queensland award program.

Cross-institutional students are subject to the rules of The University including those relating to late fees and academic progress. For clarification of these rules please consult The University of Queensland myAdvisor website www.uq.edu.au/myAdvisor. Course information is also available at www.uq.edu.au/study.

Cross-institutional students do not qualify for supplementary examinations. Students are responsible for forwarding their results to their home institutions for the awarding of credit. Official academic transcripts are available at a nominal fee.

If your application is approved you will be advised on enrolment procedures and you will be sent username and password details for online enrolment via mySI-net.

Late applications may be considered. Contact the faculty for information.

2 APPLICATION

A Cross-Institutional Admission application and *Commonwealth Support and HECS-HELP* form (undergraduate domestic students only) must be submitted and approved before students can enrol online using mySI-net (my.uq.edu.au). All students will be advised by the relevant faculty of the outcome of their application. The preferred application method is through the online application form available at <http://apply.uq.edu.au>. Alternatively you can:

1 Complete a cross-institutional admission application and *Commonwealth Support and HECS-HELP* form (undergraduate domestic students only). Ensure all sections, including the stamp of the home institution on the *HECS-HELP Status* form, are completed. Postgraduate cross-institutional students are not Commonwealth supported and are liable for full fees.

2 Provide documentary evidence of tertiary study.

Your application cannot be considered without your academic history. Attach complete, officially certified statement(s) of academic transcripts of all tertiary-level studies undertaken, except those undertaken at The University of Queensland. Photocopies must be certified by a Justice of the Peace or by the home institution. Examination result slips or copies of degree certificates are **not** acceptable. You should forward results of any studies currently being completed as soon as they are available.

3 ENROLMENT

1 Enrol by the due date on mySI-net (my.uq.edu.au).

You can obtain enrolment information from the *Enrolment Guide* available online at The University of Queensland website (www.uq.edu.au), via the my.UQ or mySI-net links. All students are required to enrol online via mySI-net. Undergraduate domestic students will be directed to submit an online '*Request for Commonwealth support and HECS-HELP*' form before enrolling. If eligible, please provide your Tax File Number, even if electing to pay upfront.

2 Pay fees by the relevant due date.

The *Enrolment Guide* gives details on due dates for enrolment, payment of charges, upfront HECS-HELP (student contribution amount) and tuition fees. Your enrolment is not effective until all fees and charges are paid. If these are not paid by the census date your enrolment may be cancelled.

3 Obtain your University of Queensland student ID card.

The *Enrolment Guide* gives details of how and when to obtain your student ID card.
