PROGRAM RULES



Bachelor of Business Management / Bachelor of Education (Secondary)

1 Definitions

In these rules—

pre-2018 student means a student who enrolled in the program before 1 January 2018; *pre-2019 student* means a student who first enrolled in the program before 1 January 2019.

2 Field of study

A student must undertake the BBusMan part of the dual program in the *Business Economics* major.

3 Program requirements

- (1) To complete the program, a student must complete 64 units from the BBusMan/BEdSec course list comprising—
 - (a) 18 units from part A; and
 - (b) 12 units for a major from part B of which 6 units must be at level 3; and
 - (c) 2 units from part B or part C; and
 - (d) 16 units from part D; and
 - (e) 16 units from part E.
- (2) Unless a different intention appear in these rules, a student must comply with the program rules for both degrees.

4 Course pre-enrolment approval

Course pre-enrolment approval is required for BEd(Sec) courses.

5 Special rules

5.1 Specialist requirements

A student must include courses that satisfy the prerequisites for two curriculum studies courses set out by the head of school of education.

5.2 Progression through program

- (1) A student must complete the requirements of the BBusMan before enrolling in courses from part E of the BBusMan/BEd(Sec) course list.
- (2) A student who fails to pass a practicum course will be required to show cause to the associate dean (academic) why enrolment should not be cancelled
- (3) A student who is required to show cause under rule 5.2(2) must do so no later than 20 business days after being required to show cause.
- (4) A student who is required to show cause may be required to attend a meeting with the head of school of education.
- (5) Show cause applications will be determined in accordance with criteria set by the associate dean (academic).
- (6) A student who has been required to show cause may have conditions set on their re-enrolment by the associate dean (academic).
- (7) A student will not be permitted to remain enrolled in the program if—
 - (a) the student fails to show cause by the due date; or
 - (b) the student's show cause application is refused; or
 - (c) the student fails to meet the conditions set on their enrolment by the associate dean (academic).
- (8) Withdrawal without academic penalty does not count as failure to pass a course.

- (9) A student who is not permitted to remain enrolled in the program under rule 5.2(7)—
 - (a) may apply for readmission into the program no less than 12 months after their enrolment has been cancelled. The executive dean may set conditions on re-enrolment.

5.3 Blue card

At the start of the program, a student must obtain a blue card and thereafter hold a current blue card for the duration of the program.

5.4 LANTITE test

Prior to graduation, a student must successfully complete the Literacy and Numeracy Test for Initial Teacher Education Students (LANTITE) as set by the Australian Institute for Teaching and School Leadership (AITSL).

5.5 Award of the Bachelor of Learning Studies (Secondary)

- (1) A student who meets all program requirements for BEd(Sec) under rule 3 but does not meet the LANTITE test requirement under rule 6.4 may be awarded the Bachelor of Learning Studies (Secondary).
- (2) The Bachelor of Learning Studies (Secondary) is not approved for teacher registration in Australia.

5.6 Transitional

- (1) A pre-2018 student must comply with the requirements of rules 5.4 and 5.5.
- (2) A pre-2019 student may choose to complete the program under the rules in force on 31 December 2018, rather than under the current rules.
