

## Bachelor of Economics / Bachelor of Science (BEcon/BSc)

### 1 Definition

In these rules—

**BEcon major** means 16 units as set out in part B of the Bachelor of Economics (BEcon) course list, with at least 8 units at level 3;

**BSc extended major** means a prescribed combination of 24 units from the extended major section of the Bachelor of Science (BSc) course list;

**BSc major** means a prescribed combination of 16 units from the major section of the BSc course list;

**BSc minor** means a prescribed combination of 8 units from the minor section of the BSc course list;

**pre-2018 student** means a student who, after 31 December 2010 but before 1 January 2018, first enrolled in—

- (a) the Bachelor of Economics/Bachelor of Science program, or
- (b) the Bachelor of Economics program;

**pre-2021 student** means a student who first enrolled in the Bachelor of Economics/Bachelor of Science program after 31 December 2017 but before 1 January 2021;

**UQ minor** means a prescribed combination of 8 units from the UQ minor section of the BSc course list.

### 2 Program requirements

- (1) To complete the program, a student must complete 64 units, comprising—
  - (a) 32 units from the BEcon course list, comprising—
    - (i) 16 units for part A (see 3.1 and 3.2 below); and
    - (ii) either—
      - (A) 16 units for a BEcon major, or
      - (B) 16 units from part C, with at least 8 units at level 3; and
  - (b) 32 units from the BSc course list, with a minimum of 10 units of courses at level 3 or higher, comprising—
    - (i) 4 units of core courses (see 3.2 below); and
    - (ii) either—
      - (A) 16 units for a BSc major, or
      - (B) 24 units for extended major; and
    - (iii) the balance of units from the BSc course list (excluding courses in the UQ minors list).
- (2) Unless a different intention appears in these rules, a student must comply with the program rules for both constituent degrees.

### 3 Special rules

#### 3.1 ECON1050

- (1) A student required to complete or who chooses to complete MATH1051 or MATH1071 for the BSc must replace ECON1050 in the BEcon with an additional course from part C of the BEcon course list.

### **3.2 ECON1310 and STAT1201/STAT1301**

- (1) A student may only complete one of ECON1310, STAT1201 or STAT1301.
- (2) If a student completes ECON1310, they must complete an additional course from the BSc course list (excluding courses in the UQ minors list).
- (3) If a student completes STAT1201 or STAT1301, they must complete an additional course from part C of the BEcon course list.
- (4) A student completing the Statistics major or minor in the BSc component of the dual program must complete STAT1201 or STAT1301.

### **4 Transitional**

- (1) A pre-2018 student may be permitted to complete the program under the current rules, rather than the rules in force on 31 December 2017.
- (2) A pre-2021 student may be permitted to complete the program under the current rules, rather than the rules in force on 31 December 2020.
