

## Bachelor of Music (Honours) / Bachelor of Education (Secondary) (BMus(Hons)/BEd(Sec))

### 1 Definitions

In these rules—

*pre-2016 student* means a student who first enrolled in the program before 1 January 2016;

*pre-2017 student* means a student who first enrolled in the program before 1 January 2017;

*pre-2018 student* means a student who first enrolled in the program before 1 January 2018;

*pre-2020 student* means a student who first enrolled in the program before 1 January 2020;

*pre-2021 student* means a student who first enrolled in the program after 31 December 2019 but before 1 January 2021;

*professional year* means the final 16 units of the BEd(Sec) component of the dual program, comprising professional year core courses and professional year curriculum studies courses.

### 2 Program requirements

- (1) To complete the program, a student must complete 80 units, comprising—
  - (a) 48 units from the BMus(Hons) section of the BMus(Hons)/BEd (Sec) course list, comprising—
    - (i) 26 units for core courses, and
    - (ii) 12 units from flexible core courses, and
    - (iii) 10 units for research courses; and
  - (b) 32 units from the BEd(Sec) section of the BMus(Hons)/BEd (Sec) course list, comprising—
    - (i) 16 units for Core Courses, and
    - (ii) 8 units for Professional Year Core Courses, and
    - (iii) 8 units from Professional Year Curriculum Studies Courses.
- (2) Unless a different intention appears in these rules, a student must comply with the program rules for both constituent degrees.

### 3 Special rules

#### 3.1 Course pre-enrolment approval

Course pre-enrolment approval is required for BEd(Sec) courses.

#### 3.2 Specialist requirements

In selecting courses from the BMus(Hons) course list, a student must include courses that satisfy the prerequisites for two curriculum studies courses set by the head of the school of education.

#### 3.3 Progression through program

- (1) A student must complete the requirements for the BMus(Hons) and BEd(Sec) core courses before enrolling in the BEd(Sec) professional year.
- (2) Students must undertake the professional year on a full-time basis, commencing in Semester 1 only.

#### 3.4 Blue card

At the start of the program, a student must obtain a blue card and thereafter hold a current blue card for the duration of the program.

### **3.5 LANTITE test**

Prior to graduation, a student must successfully complete the Literacy and Numeracy Test for Initial Teacher Education Students (LANTITE).

### **3.6 Award of the Bachelor of Music (Honours) and the Bachelor of Learning Studies (Secondary)**

- (1) A student who meets all program requirements for BMus(Hons)/BEd(Sec) under rule 2 but does not meet the LANTITE test requirement under rule 3.5 may be awarded the Bachelor of Music (Honours) and Bachelor of Learning Studies (Secondary).
- (2) The Bachelor of Learning Studies (Secondary) is not approved for teacher registration in Australia.

## **4 Transitional**

- (1) A pre-2016 student may complete the program under the current rules or the rules in force on 31 December 2015.
- (2) A pre-2017 student may complete the program under the current rules or the rules in force on 31 December 2016.
- (3) A pre-2018 student may complete the program under the current rules or the rules in force on 31 December 2017.
- (4) A pre-2020 student may complete the program under the current rules or the rules in force on 31 December 2019.
- (5) A pre-2021 student may complete the program under the rules in force at the time of enrolment.
