- 30 units from the BBusMan course list, including
 - o 14 units from Part A (excluding LAWS1100); and
 - 16 units for a BBusMan major; and
- 48 units from the LLB(Hons) course list, including
 - o 36 units for Part A; and
 - o 12 units from Part B; and
- 2 units of general elective courses
