Students will then be required to follow the single degree rules to complete the remaining component from that dual degree and maximum credit rules will apply.

PROGRAM GUIDELINES

You must complete 80 units, comprising -

- 30 units from the BCom course list, including
 - o 14 units for Part A (excluding LAWS1100); and
 - 16 units for a BCom major; and
- 48 units from the LLB(Hons) course list, including
 - o 36 units for Part A; and
 - o 12 units from Part B; and
- 2 units of general elective courses

• LAWS5144 must be completed if taking an Accounting major (for professional accreditation purposes)
