<u>Please note:</u> Students exiting early with one component of a dual degree must complete the single degree requirements of that component. Students will then be required to follow the single degree rules to complete the remaining component from that dual degree and maximum credit rules will apply.

### **PROGRAM GUIDELINES**

You must complete 80 units, comprising –

- 30 units from the BCom component, including
  - o 14 units for all BCom Core Courses for the BCom/LLB(Hons); and
  - o 16 units for a BCom major; and
- 48 units from the LLB(Hons) component, including
  - 36 units for all LLB(Hons) Core Courses; and
  - o 12 units from LLB(Hons) Flexible Core Courses; and
- 2 units of general elective courses

• LAWS5144 must be completed if taking an Accounting major (for professional accreditation purposes)
