You must complete 80 units, comprising -

- 30 units from the BBusMan course list, including
 - o 14 units for all BBusMan Core Courses for the BBusMan/LLB(Hons); and
 - $\circ~$ 16 units for one major from BBusMan Majors; and
- 48 units from the LLB(Hons) course list, including -
 - 36 units for all LLB(Hons) Core Courses; and
 - o 12 units from LLB(Hons) Flexible Core Courses; and
- 2 units of General Elective Courses
