PROGRAM GUIDELINES

You must complete 80 units, comprising -

- 30 units from the BCom component, including -
 - 14 units for all BCom Core Courses for the BCom/LLB(Hons); and
 - $_{\odot}$ $\,$ 16 units for a BCom Major from BCom Majors for BCom/LLB(Hons); and
- 48 units from the LLB(Hons) component, including -
 - 36 units for all LLB(Hons) Core Courses; and
 - o 12 units from LLB(Hons) Flexible Core Courses; and
- 2 units of General Elective Courses
