

# Bachelor of Business Management/Bachelor of Laws (Honours) 2025 Dual Program Structure

To be eligible to enrol in a dual degree program you must ensure that you satisfy the entry requirements for both programs.

Once enrolled it is your responsibility to ensure that you complete all the requirements for each section of this dual program in order to graduate with both degrees. **Please note:** Students exiting early with one component of a dual program must complete the single program requirements of that component. Students will then be required to follow the single program requirements to complete the remaining component from that dual program and maximum credit rules will apply.

## PROGRAM GUIDELINES

You must complete 80 units, comprising –

- 30 units from the BBusMan course list, including –
  - 14 units for all BBusMan Core Courses for the BBusMan/LLB(Hons); and
  - 16 units for one major from BBusMan Majors; and
- 48 units from the LLB(Hons) course list, including –
  - 36 units for all LLB(Hons) Core Courses; and
  - 12 units from LLB(Hons) Flexible Core Courses; and
- 2 units of General Elective Courses
